### 73 APOLOGIES

Apologies for Absence were received from Councillors Blackmore, Gilbert, Ivory and Rogers.

Councillor Crabtree declared a personal interest in Item 77.2 as he was arranging the Christmas tree.

#### 75 CONFIRMATION OF MINUTES

It was agreed by Members that the Minutes be signed by the Chairman as a true and correct record.

With the deletion of Item 70 paragraph two as the Council had been informed that the town team did not have public liability as yet.

# **76 COMMUNITY REPORTS**

# **76.1** District Councillors

Councillor Wassell reminded Members that the date for the forthcoming Could We/Should We Town meeting for Watton would be held on Thursday 2 October 2012 at the Queens Hall at 7pm. Meetings had already been held at Thetford, Dereham and Attleborough. Swaffham was Thursday 27 September.

A very positive response had been received, with attendees appreciating being informed. Many supported Car Park Charges and Council Tax raises, the survey is also available on the Breckland web site.

Boundary Commission Changes review had been caused by an electoral imbalance in two wards in Breckland. The idea being that elected members should represent the same number of electors as their colleagues. At present the average in Breckland is 1830. Watton = 1940, Templar = 2416, 33% over, trigger is 30% one of the Dereham wards is 35% over. All ward boundaries will be re-drawn as part of this exercise.

The review does **not** look at parish matters, focusing only on the Electoral arrangements at district ward level; therefore the Commission will not be looking at parish boundaries or any parish Council

related issues. Parishes will be consulted. A briefing for Town & Parish councils will be held on 25 October - 2 sessions starting at 2pm or 3:30pm.

The Current Council Tax Benefit Scheme will cease next year and be replaced on 1 April by Council Tax Support Scheme with 10% less funding!

Local Authorities will be allowed to develop their own scheme. The scheme will protect pensioners and the vulnerable. Consultation will take place before it is implemented which can be found on the Breckland website.

#### 77 URGENT BUSINESS

77.1 The Chairman asked those members who had attended the car parking meeting with Steve James the Breckland Representative for a report on the meeting.

All members who attended felt that the presentation was impressive and was explained very well.

77.2 The Chairman informed and was agreed that the costs for the Christmas tree and lights would be approximately £1000.00 which was within the budgeted amount. It was agreed that a letter be sent to the person who was donating the tree.

#### 78 CHAIRMAN'S REPORT

The Chairman asked again that Members keep visits to the office to the afternoon unless the matter is urgent as this is when the office is open to the public.

He pointed out a forthcoming proposed planning application 3PL/2012/0820/CU at Otterwood Kennels, Watton Road, Saham Toney. While he appreciated it was outside the Watton boundary, the implications of this planning application could have an impact on the area. The Agent Stuart Carruthers is the representative for Dale Farm, Basildon, Essex.
