### **GRANTS**

## **PLANNING APPLICATIONS**

3PL/2015/0219/F – Mr Chris Smith – Hopkins Homes Limited, Melton Park House, Scott Lane, Melton, Woodbridge, Suffolk IP12 1TJ – Land west of Saham Road – Residential Development comprising the erection of 73 Dwellings together with associated open space.

It was agreed to recommend refusal of this application as the same concerns remain as were noted with the previous proposed development of this site which was refused permission.

3PL/2014/1253 – Gladman’s Developments Ltd – Land off Thetford Road, Watton – Outline application for residential development, involving up to 180 dwellings, provision of open space with recreational facilities, site access and all with associated highways and infrastructure works.

All agreed to recommend refusal.

3PL/2015/0254 – Mr Mark Dakeyne, Janet Strickland – Miller, Nicholas Rickett & Tesni Properties Ltd – Bidwells – Outline Planning Application for residential development of up to 177 dwellings on Land South of Mallard Road and Woodpecker Drive Watton, Norfolk.
