The Town Council has decided to undertake a Neighbourhood Plan and a presentation was given briefly outlining the Neighbourhood Planning process and what it is hoped will be achieved from the engagement with the community which this project will bring. A second presentation was given to launch thoughts for the initial idea which is being investigated to provide facilities within the town fit for the 21st Century. It is hoped by organisations already consulted that partnership working may lead to enhanced facilities being provided. A copy of the presentation will be made available.

11. Questions submitted by attendees

- What is the Town Council actively doing to highlight the facts of unsustainability of agreed new builds and further applications for development in Watton?
- What steps are the Town Council taking to promote new businesses to the town to create jobs?
- What plans have the town council got to create a proper park in the town where families can have barbecues, have picnics, kick a ball about, just sit and enjoy what is going on?
- What are the TC doing to promote the high street and revitalise it?

- What is the result of the various meetings the TC have had to overcome the worrisome floods within the town and the meeting with our illustrious MP, George Freeman?
- What is the TC doing to promote proper facilities for the youth of the town?
- What plans have the TC got to stop adults riding cycles on the pavements that are not cycle paths and getting them to ride in the road where they should be?
- "We were not informed of Tesni's intention to build 177 homes in the fields at the end of Woodpecker Drive and Mallard Road when we bought our bungalow!!! The field touches our fence!!
 We are therefore very keen to know what Watton's Council's attitude is towards this APPLICATION, i.e. are you in favour of this Application for 177 homes bearing in mind it will bring a minimum of 500+ more people into Watton and they could use our few shops we have in Watton and the GP surgery will be struggling more than ever to work efficiently to mention but a few issues, and Watton roads could not cope with the extra traffic or

will you be against the APPLICATION bearing in mind that Watton could not cope with another 500 PLUS people arriving in Watton - not to mention possibly another 350 cars plus on our busy, narrow, congested roads in Watton No jobs, not enough shops, facilities, no full time active police station, a GP surgery struggling to cope now, the drainage system in Woodpecker Drive is now supposed to being dealt with before the drains collapse. The problems being encountered by this Application are unbearable!"
