2. To accept NP meeting notes from 9th December 2019

The notes from the NP meeting held on December 9th were accepted as presented.

• It was noted that the draft NP is slightly behind schedule but will be prepared for the end of February 2020.

3. AECOM – Technical Support Update

- First draft of the Watton Town Centre Design Code plan received from AECOM on 10th February. Plan been circulated to steering group members and viewed electronically at the steering group meeting. Comments to Jane Fountain.
- JF to report to the Town Council meeting within her Vice Chairman's report on February 11th that the draft design Code plan has been received.
- MT to circulate Design Code plan to all councillors with any comments from councillors or NPWG members to be forwarded to JF to be collated and sent to NF by Friday 21st February.
- The Design Code plan contains a Signage Audit which could be useful for the Heritage Map project.
- Due to the fire in the High Street, it has been discussed to potentially move the market to Middle Street temporarily to accommodate the market traders, a temporary road closure to be looked into.

Digital and Creative Media Centre (DCMC) Update

• Written draft building brief circulated to steering group members.

In his introduction David Dent made clear that the Wayland Chamber of Commerce is only facilitating the development of the DCMC on behalf of, and in partnership with, the Wayland Partnership. The DCMC will be owned by the Wayland Partnership and the property managed by a third party on behalf of the Partnership.

Initial planning to define the functional space of the centre is underway with the first draft under consideration by the Trustees of the Wayland Partnership. Hethel Innovation will support business plan preparation, assisting with building design specifications and architectural inputs.

A meeting on 5th March has been arranged between David Dent and Bronwen Tyler and Norfolk County Council Officers and Cllr Claire Bowes to consider integration of the Watton library into the proposed Centre.

Breckland Council are fully aware of the proposals and are supportive of the initiative, as is George Freeman MP.

Hethel Innovation continue to support the initiative, are keen to see a digital and creative media incubator for business established in mid-Norfolk and ultimately are interested in managing the site on behalf of the Wayland Partnership.

This proposal has the support of George Freeman MP, Sam Chapman – Allen (Leader BDC) and Simon Hughes (NCC)

• Watton Medical Practice Patient Participation Group (PPG) – JF to attend and provide a presentation on the NP.
